# **Session 1: Introduction and Qualifications for Deliverance**

#### **Qualifications for deliverance**

They must have accepted Christ as their Savior.

Christ must be the Lord of their life, or they must be ready to make Him Lord

They must be willing to live "clean"

They must completely forgive everyone

They must be willing to give up ungodly relationships (soul ties)

They must confess any unconfessed sin (privately)

They must come out of agreement with ungodly beliefs.

They must be active in a local church.

**Salvation:** The candidate must give you a profession of faith, and a testimony of their conversion. Their conversion must state the fact that they were separated from God because of sin with no way to heaven. They must have confessed their sin. And they must have mad Christ Lord of their life. Complete deliverance done without salvation can have severe consequences.

#### Deliverance is for the believer or for the conversion of an unbeliever.

**Matthew 15:22-28 NIV**<sup>22</sup> A Canaanite woman from that vicinity came to him, crying out, "Lord, Son of David, have mercy on me! My daughter is demon-possessed and suffering terribly."<sup>23</sup> Jesus did not answer a word. So, his disciples came to him and urged him, "Send her away, for she keeps crying out after us."<sup>24</sup> He answered, "I was sent only to the lost sheep of Israel."<sup>25</sup> The woman came and knelt before him. "Lord, help me!" she said.<sup>26</sup> He replied, "It is not right to take the children's bread and toss it to the dogs."<sup>27</sup> "Yes, it is, Lord," she said. "Even the dogs eat the crumbs that fall from their master's table."<sup>28</sup> Then Jesus said to her, "Woman, you have great faith! Your request is granted." And her daughter was healed at that moment.

Full deliverance on a person who is not saved will allow the "house" to be swept clean and the demonic will be allowed to return seven times worse.

**Matthew 12:43-45 NIV**<sup>43</sup> "When an impure spirit comes out of a person, it goes through arid places seeking rest and does not find it. <sup>44</sup> Then it says, 'I will return to the house I left.' When it arrives, it finds the house unoccupied, swept clean and put in order. <sup>45</sup> Then it goes and takes with it seven other spirits more wicked than itself, and they go in and live there. And the final condition of that person is worse than the first. That is how it will be with this wicked generation."

# Session 2: Gateways and "Legal Rights" of the Oppressors

Gateways to oppression: Refer to Don Dickerman's list on page 218 of When Pigs Move In

## "Legal rights" of demons that must be broken

**Unforgiveness:** This is a big one. In the parable of the unforgiving servant in Matthew 18, the king turned the unforgiving servant over to the tormentors. This is what happens with us when we hold onto bitterness, hate, and unforgiveness towards others. This is the ultimate insult to God as He gave His son as a sacrifice for us to have forgiveness. Because of this, God allows us to be turned over to the tormentors if we refuse to forgive. Your unforgiveness gives demons the legal right to set up oppressive kingdoms.

**Matthew 18:31-35 The parable of the unforgiving servant** So when his fellow servants saw what was done, they were very sorry, and came and told unto their lord all that was done. Then his lord, after that he had called him, said unto him, O thou wicked servant, I forgave thee all that debt, because thou desiredst me: Shouldest not thou also have had compassion on thy fellow servant, even as I had pity on thee? And his lord was wroth, and delivered him to the tormentors, till he should pay all that was due unto him. So likewise, shall my heavenly Father do also, unto you, if ye from your hearts forgive not everyone his brother their trespasses. To break this, you must have the candidate forgive anyone for whom they may have unforgiveness. This is quite simple. Do not try and make it complicated. have them list out those that need to be forgiven and then go through the list and forgive each person in their mind. They do not need to be specific about why, they just need to be thorough to break the legal right. Make sure they forgive themselves.

**Mark 11:25** Whenever you stand praying, forgive, if you have anything against anyone, so that your Father who is in heaven will also forgive you your transgressions.

#### **Prayer for forgiveness**

Lord, I choose to forgive all those who have sinned against me, hurt me, or even abused me. I repent of all unforgiveness for others and confess it as sin. Lord, I want to specifically forgive (name the people that you may have struggled to forgive,) and I also choose to forgive myself. Thank you for your grace, mercy, and love. Amen

**Soul ties:** The candidate must confess any ungodly relationship or sexual relationship outside of marriage as sin and break the soul tie with that person.

**1 Samuel 18:1** NIV After David had finished talking with Saul, Jonathan became one in spirit with David, and he loved him as himself.

**I Corinthians 6:16** NIV Do you not know that he who unites himself with a prostitute is one with her body? For. it is said, "The two will become one flesh."

Genesis 2:24 NIV This is why a man leaves his father and mother and is united to his wife, and they become one flesh.

**Ephesians 5:31** For this reason a man will leave his father and mother and be united to his wife, and the two will become one flesh.

#### **Prayer for breaking soul-ties**

Lord, I want to renounce every ungodly relationship that I may have interred into and recognize it as sin. I call back every part of me that was given to another, and I give back every part of others that I may have taken. In the name of Jesus, I break every ungodly soul tie that I have made and choose to be free from every ungodly attachment. Amen.

**Unconfessed Sin**: It is essential that the candidate confess all sin before God. They do not need to confess these sins aloud, however; you must give them time to quietly examine their life, confessing anything that they recognize as sin before deliverance begins.

**1 John 1:9** If we confess our sins, He is faithful and righteous to forgive us our sins and to cleanse us from all unrighteousness.

**Ungodly beliefs:** Many people have ungodly beliefs about themselves. These beliefs can bring demonic attachments that may use these beliefs as their legal right to stay attached. The following are examples of ungodly beliefs:

I am a mistake	I am loser	I am ugly	I am gay
I am worthless	I must be perfect	I am unwanted	I am damage
I am a failure	I have ADD	I cannot change	I am always angry

To break these, have the person renounce their ungodly beliefs and confess them as sin. "I renounce the belief that I am a failure, and I confess it as sin." Candidates must be willing to give up the beliefs that they may have lived with their entire life. If they will not let go of these beliefs, then you may not be able to cast out the attached demon group. "You can't cast out their buddies"

The use of ungodly objects to connect with God or to bring healing: Many

people will use ungodly objects in prayer or for healing that will allow demonic attachments in their life. This usually comes as a spirit of witchcraft or Kundalini. This may include such things as candles, incense, sage, essential oils, crystals, or even vitamins. People will argue with you that many of these items are created by God and cannot bring on a spirit of witchcraft. It is not the objects that bring the attachments, it is the person reliance on these items to connect with God or bring healing. Specifically, essential oils and vitamins can bring on kingdoms of false healing as they may be used to replace Biblical healing. Have the person renounce the use of any items used to connect with God. Likewise, have them renounce the use of anything that may be used to replace Biblical healing. For example:

Lord, I renounce the use of candles to connect with God. I confess this as sin and ask forgiveness.

Lord, I renounce my reliance on essential oils or vitamins that have replaced your healing power in my life. I confess this as sin and ask forgiveness.

This is an area where you will many times face resistance from a deliverance candidate. If there is an un-Godly use of these items, then it will show up in the deliverance. The spirts of witchcraft or false healing will claim this as their legal right, and the person will have to renounce these things for these kingdoms to be cast out. Also, yoga including Christian yoga and new age meditation will bring on a Kundalini spirit. Yoga uses ancient body positions used in demon worship. It must be renounced.

#### Curses (Generational, Sins of ancestors, ungodly oaths, and word curses)

The process of breaking curses should not be ritualistic. It should be quite simple. In the physical realm, most of the time words have little power. This has been ingrained in us since childhood. "Sticks and stones may break my bones, but words can never hurt me." In the spiritual realm, words have great authority. There are many types of curses that may be on a person. There may be generational curses from ancestorial sins, word curses like fat or lazy, witchcraft curses from the occult including voodoo, santeria, brujeria, and curses from witches and warlocks. There are also ungodly oaths that may be taken with secret societies such as freemasonry, fraternities, and sororities. Very few recognize the power that is given with spoken words. The scripture explains this in Proverbs 18:21 and Matthew 12:37. Your enemy understands this power. To be effective in breaking curses and combating the enemy, you must understand the power that you have been given through your words in the name of Jesus.

**Freemasonry oppression:** Fear of a noose around the neck, death by choking, asthma, hay fever, breathing problems, eye problems, throat problems, digestive problems, heart attack, rape, murder, confusion, and death by stabbing,

Proverbs 18:21 Tells us that our words can bring death or life.

Matthew 12:37 The words you say will either acquit you or condemn you.

#### Generational curses (Sins of fathers and forefathers)

**Exodus 20:5** NIV <sup>5</sup> You shall not bow down to them or worship them; for I, the LORD your God, am a jealous God, punishing the children for the sin of the parents to the third and fourth generation of those who hate me,

**Exodus 34:7** NIV <sup>7</sup> maintaining love to thousands, and forgiving wickedness, **rebellion**, and sin. Yet he does not leave the guilty unpunished; he punishes the children and their children for the sin of the parents to the third and fourth generation."

**Numbers 14:18 NIV**<sup>18</sup> 'The LORD is slow to anger, abounding in love and forgiving sin and rebellion. Yet he does not leave the guilty unpunished; he punishes the children for the sin of the parents to the third and fourth generation.'

**Deuteronomy 5:9** NIV <sup>9</sup> You shall not bow down to them or worship them; for I, the LORD your God, am a jealous God, punishing the children for the sin of the parents to the third and fourth generation of those who hate me,

#### Prayer for breaking generational sins and curses

Lord, right now I ask that all the sins of my fathers and forefathers and every attached curse be brought before you. We know that the blood of Your Son covers all sins and turns every curse into a blessing. Lord, I confess and denounce the sins of my ancestors, and ask that the blood of Your Son be applied to every sin and curse in my lineage breaking every legal right of the enemy. Father, thank you for forgiving these sins and separating me from the curses on my life. Amen.

# Session 3: Operating in the Courts of Heaven

**Galatians 3:13-14** "But Christ has rescued us from the curse pronounced by the law. When He was hung on the cross, he took upon Himself the curse for our wrongdoing. For it is written in the Scriptures, "Cursed is everyone who is hung on a tree." Through Christ Jesus, God has blessed the Gentiles with the same blessing He promised to Abraham, so that we who are believers might receive the promised Holy Spirit through faith."

John 5:14-15 "And we are confident that He hears us whenever we ask for anything that pleases Him. And since we know He hears us when we make our requests, we also know that He will give us what we ask for."

**Luke 18:1-8** In the parable of the persistent widow, we are given the example of God sitting as judge granting the petitions of his people. This scripture also says that He will grant justice speedily. Once the verdict has been given, justice will come quickly.

One day Jesus told his disciples a story to show that they should always pray and never give up. "There was a judge in a certain city," he said, "who neither feared God nor cared about people. A widow of that city came to him repeatedly, saying, 'Give me justice in this dispute with my enemy.' The judge ignored her for a while, but finally he said to himself, 'I don't fear God or care about people, but this woman is driving me crazy. I'm going to see that she gets justice, because she is wearing me out with her constant requests!' Then the Lord said, "Learn a lesson from this unjust judge. Even he rendered a just decision in the end. So don't you think God will surely give justice to his chosen people who cry out to him day and night? Will he keep putting them off? I tell you, he will grant justice to them quickly! But when the Son of Man<sup>[a]</sup> returns, how many will he find on the earth who have faith?"

**Psalms 82:1** "God presides over heaven's court; he pronounces judgment on the heavenly beings."

**Revelations 19:11** This scripture tells us that heaven is open to us. Our king is faithful and true. He judges and renders verdicts and wages war on our behalf. This is done in a specific order: petition, judgement, war. This is how we should approach the courts. Make our request, get a judgement, and then go to war in deliverance. "Then I saw heaven opened, and a white horse was standing there. Its rider was named Faithful and True, for He judges fairly and wages a righteous war." This scripture tells us that heaven is open to us. Our king is faithful and true. He judges and renders verdicts and wages war on our behalf. This is done in a specific order: petition, judgement, war.

Genesis 50:15-17 Jacob interceded for his sons and asked forgiveness for their sins. Then Joseph's brothers saw that their father was dead, they said, "What if Joseph holds a grudge against us and pays us back for all the wrongs, we did to him?" So they sent word to Joseph, saying, "Your father left these instructions before he died: 'This is what you are to say to Joseph: I ask you to forgive your brothers the sins and the wrongs they committed in treating you so badly.' Now please forgive the sins of the servants of the God of your father." When their message came to him, Joseph wept.

**Job 42:7-9** (Job represents his friends before God) After the LORD had said these things to Job, he said to Eliphaz the Temanite, "I am angry with you and your two friends, because you have not spoken the truth about me, as my servant Job has. So now take seven bulls and seven rams and go to my servant Job and sacrifice a burnt offering for yourselves. My servant Job will pray for you, and I will accept his prayer and not deal with you according to your folly. You have not spoken the truth about me, as my servant Job has." <sup>9</sup> So Eliphaz the Temanite, Bildad the Shuhite and Zophar the Naamathite did what the LORD told them; and the LORD accepted Job's prayer.

# **Breaking Curses in the Courts of Heaven**

Curses can be broken individually, however; We have found that all the curses can be broken off a person at one time by going to the courts of heaven. This is done by opening a court of judgement and asking that Jehovah God to apply the blood of His Son to the curses, turning them into blessings. You must have the candidate's permission to do this. ask the candidate, "Can I represent you in the courts of heaven before Jehovah God?" This is the process of breaking the curses:

To begin with, ask God if you can open a court of judgement. This is the same concept used in **Job 42:7-9** where Job is allowed to represent his friends before God and because of Job's representation in prayer, they were not judged. You should hear a yes in your conscious. You may see the court in your mind. It may look like the supreme court with Jehovah God sitting as the head judge along with other judges who are saints sitting on either side. You may not see the court; it does not matter. The bailiffs are angels. Ask Jehovah God if you can represent the deliverance candidate. You will act as their attorney in the court. You will usually have a thought of yes or no. As you stand before Jehovah God, ask that the curses against the person be brought into the courtroom. The bailiffs will bring the curses into the court. You may see boxes containing curses being brought into the court on carts. Some people will even see trucks backing up loaded with their curses. Every person may see something different, or they may see nothing. The blood of Jesus has paid for all our curses at the cross allowing them to be turned into blessings, however; the blood must be applied to the curses for the curses to be broken.

Galatians 3:13-14 But Christ has rescued us from the curse pronounced by the law. When He was hung on the cross, he took upon himself the curse for our wrongdoing. For it is written in the Scriptures, "Cursed is everyone who is hung on a tree. Through Christ Jesus, God has blessed the Gentiles with the same blessing he promised to Abraham, so that we who are believers might receive the promised Holy Spirit through faith.

This is the same process that was used in Egypt at Passover when the blood was applied to the doorpost destroying the curse of death of the firstborn against a household. Breaking this curse is what led to the deliverance of the Israelites from slavery. Breaking these curses on a deliverance candidate is what will lead them to deliverance from the demonic. **In Exodus 12:13-28**, at Passover, the blood was applied to the doorpost destroying the curse of death of the firstborn on a household. One person applying the blood broke the curse on all the others in the household. Breaking this curse is what led to the deliverance of the Israelites from slavery. Breaking these curses on a deliverance is what led to the deliverance of the Israelites from slavery. Breaking these curses on a deliverance candidate is what will lead them to deliverance from the demonic.

At this point, you need to petition Jehovah God to have the bailiffs apply the blood of His Son to every curse turning the curses into blessings. You may see angels with pitchers pouring the blood over the curses, some people with many curses will see their curses being sprayed with blood by the angels, some have seen the blood being painted on their curses, others may see nothing. This will usually depend on the spiritual gifts of the person. Spirit filled believers will usually see more. When the blood is applied, it will turn every curse into a blessing. You will then get a judgement from Jehovah God as the supreme judge that the curses had been broken and turned into blessings. Once again, this is not complicated so do not make it complicated.

# **Prayer to Break Curses**

Lord, can I open a court of judgement. (You will normally receive a yes in your conscious.) Lord, as I stand before you now, may I be allowed to represent \_\_\_\_\_\_\_ (the deliverance candidate) in court before You today. Lord, I want to ask that right now every curse against \_\_\_\_\_\_\_ be brought into court by the bailiffs. (Wait for the curses to be brought into court.) Lord, will you have the bailiffs apply the blood of Your Son to every curse turning them into blessings. (Wait for the blood to be applied.) Lord has the blood been applied and have the curses been turned into blessings. You will normally receive a yes in your conscious.)

Not only can you use this process to break curses off people, but it can be used to break curses off land, churches, houses, etc. It is as simple as having the curses against a house or church brought into court and having the blood applied to the curses turning them into blessings. Parents can also break curses off their children because they have all authority over their kids. You cannot usually represent someone without their permission unless they have a mental disability. You can sometimes represent the elderly, mentally disabled, or mentally incompetent in the courts. All you must do is ask Jehovah if you can represent someone in court. You will hear a yes or no in your conscious.

Does this really work? Yes! When you ask a demon if they have a legal right to be in their host, they will tell you yes or no. When you break the curses in the court, the demons will tell you that they no longer have a legal right tied to a curse. When asked, they will verify that their legal right was broken in the court. Although this works on generational curses, it does not break unforgiveness. Forgiveness for others must come from the deliverance candidate.

# How to take out a protective order in the heaven's courts

To take out a protective order in the heaven's courts, you ask God the Father if you can open a court before Him. You should hear a yes. You say something like this, Lord, I would like to ask for a protective order to be issued over me, over everyone in this deliverance, over my house,

over my land, over my child, etc. You should hear and answer as a thought of yes or no in your mind. If it is a yes, ask for a time limit for the protective order. Ex. Can you issue this for three days, a week, or a month. Protective orders are not open-ended in our court system, so it is best to ask for a time limit. When you "hear" a yes, then say Lord, can you give me angelic protection to enforce this protective order. As in the real world, protective orders do not come with automatic police protection. You must ask. It is the same with the heavenly courts. You must ask for angelic protection to enforce the protective order. When you get a yes, you can thank the Father who is the ultimate judge, and the protective order will be put into place. If you have a demon violate the protective order, then you can open a court and report the demon for violating the protective order. You then ask that the demon be tried for this violation, and he will be removed and prosecuted. We do this for ourselves, our kids, meetings, meeting places, churches, etc. Do not try and take out a protective order over evil or ungodly people or buildings. If there is a person or place in agreement with evil, you will not be able to take out a protective order. The protective order is the way that we bring angelic protection over a deliverance, over a building where we are teaching, and over ourselves and our families as we engage in spiritual warfare.

# How to prosecute demons in the Courts of Heaven.

There will be times in a deliverance when you will deal with a stubborn demon or group of demons. They may not want to leave even though they have no "legal right" to stay. When this happens, we will usually command the demon to obey in the name of Jesus Christ. As Christians, we have all authority in the name of Jesus, and the demons must obey, however; there will be times when they will still refuse to leave. What happens next may be like an episode of the television show cops. The police officer may corner a suspect. The officer has all authority to make the criminal put his hands behind his back to be arrested, however; there are times when the criminal will disobey those commands. They may lie. They may fight. They may run disobeying the authority given to the officer. Everything changes when they are caught and brought into court. At that point, they are put on trial, judged, and sentenced. They are then removed from the court and carried to jail. You can do the exact same thing with demonic spirits in a deliverance if they refuse to obey the name of Jesus. This is what this looks like during a deliverance. After breaking the legal rights, we will command the demon to leave. Sometimes the demon will refuse to leave or want to argue. At that point we will tell the demon, if you do not want to leave, I will open a court of judgement and have you prosecuted for disobeying my authority in the name of Jesus Christ. I will ask for a sentence of seven times more torment throughout eternity. (Sometimes 10xs or even 100xs more torment depending on the belligerence of the demon) You then tell the demon that they have a choice. They can obey the name of Jesus and go into the abyss, or they can choose to be brought before Jehovah God, the Father, the Creator, and be tried for disobeying the name of Jesus. We make them choose one or the other. Most will leave when threatened. Some will refuse saying that you do not know how to do that or even say, go ahead and take me to court. If they refuse to leave, then this is the process of prosecuting the demon.

You ask the deliverance candidate if you can represent them in the courts of heaven acting as their attorney. This may have already been done while breaking curses in the courts. Once the candidate agrees, you begin by saying, Lord, I would like to open a court of judgement. Father,

right now I am dealing with the spirit of fear and all its associated demons, or you can be more specific. Father I am dealing with Apollyon and all his associated demons. I have commanded these demons to leave in the name of Your Son, and they have disobeyed my authority in the name of Jesus. I would like to have these demons brought into court, and I would like to have them prosecuted for disobeying the name of Jesus. Will you have the bailiffs (Angels) bring them into the court? You will usually hear a yes or, "bring them into the court." When they are brought into the court, you will begin the trial. Lord these demons have disobeyed my authority in the name of Jesus. I would like to have these demons prosecuted for disobeying the name of Your Son. I would ask that these demons be sentenced to seven times more punishment throughout eternity. Right now, I would ask that the blood of Your Son testify on (name your deliverance candidate) behalf. Father, will you give me a verdict of guilty and have these demons removed and carried to the pit to serve their sentence? (You will usually then hear a verdict of guilty and the demons will be removed from the person.) We usually end the trial by saying thank you Father, and then we go back to the deliverance. We normally ask the next demon if the previous demons were removed. It is usually a yes, however; sometimes they will lie and say no. Call them a liar and command them to tell the truth. It is always a yes. Opening a court and trying a demon group usually sets a precedent because the others do not want to be tried before Jehovah God. You may have to do it again with others, but it usually terrifies the others into submission. They will not want to be judged. If you have not broken the "legal rights" on all the demons that were brought into the court, then the demons with a right to oppress will be left behind while the others are removed. You must break all legal rights before you have them tried

# **Session 4: Deliverance Commands and Deliverance**

## Commands to quickly take authority over a demon

Take authority by three things: The blood of Jesus Christ Luke 10:19 The call of the great commission

You can use a basic command to take authority over a demon at any time. We always take authority using three things: **The blood of Jesus Christ, Luke 10:19, and the call of the great commission**. It can be in any order, but we have found that these three areas will start a deliverance rapidly.

**Mark 16:15-19 NLT** He said to them, "Go into all the world and preach the gospel to all creation. Whoever believes and is baptized will be saved, but whoever does not believe will be condemned. And these signs will accompany those who believe: In my name they will drive out demons; they will speak in new tongues; they will pick up snakes with their hands; and when they drink deadly poison, it will not hurt them at all; they will place their hands on sick people, and they will get well."

Luke 101:19 KJV Behold, I give unto you power to tread on serpents and scorpions, and over all the power of the enemy: and nothing shall by any means hurt you.

## How to prepare a person for their session

As we start a deliverance, we command any demonic attachments to speak to the conscious mind of the person whom we are doing deliverance or speak through them. Sounds weird and spooky, but it is not. The person will begin getting thoughts and images as the deliverance begins. It will go something like this: In the name of my Savior Jesus Christ, is there a spirit of anxiety there. In the name of Jesus, you give me a yes or no. The person will usually have an immediate thought of yes or no. In the name of Jesus, I command that the king of anxiety come to the front and stand before all others. The deliverance candidate will many times say, "I cannot believe I am hearing and seeing these things." The truth is that they have always seen and heard things put there by demonic oppression, but they never recognized it. You must never have random conversation with a demon. It is divination and it is an abomination to God. All communication with a demon must be for interrogation with the intent of destroying the attachment. Random communication is a gateway to an attachment of witchcraft. **Deuteronomy 18:10-11** 

# Basic commands to begin a deliverance

-Now in the name of Jesus Christ, by the calling of the great commission, the power of the blood of Jesus Christ my Savior, and by the authority given to me in **Luke 10:19**, I take absolute control over every demonic power in this house. You will hear my commands and you will obey in the name of Jesus Christ my Savior, or you will be judged in the court of Jehovah God. I command in the name of Jesus that every demonic power stand at attention before Jehovah God. I bind every demonic power in the house, and command in the name of Jesus that every demonic be put into holy handcuffs and holy chains. I command that you do not move.

# Stripping demons of their power, promotions, and ranks

All demons have specific powers. Like humans, some will be more powerful than others. Demonic kingdoms operating in a person will also have ranks much like the military. There will be kings, commanders, captains, lieutenants, and privates. They will have received promotions throughout the years, and they will be numbered from least important to the most important. The one ranked number one will be the strongman, the king, the boss. The lowest ranked demons are called plebes. Luke 10:19 gives us the authority over all the power of the enemy. What this allows you to do is to strip a demon of their power, authority, and titles. The leaders will even have robes, rings, and regalia.

## 4 things you must do when casting out a demon

(They consider you a home and refer to you as their house)

- 1. Command every demonic power to return the house back to the way God created it (put the house back in order)
- 2. Command that they pack up everything that they brought into the house leaving nothing behind (pack up everything you brought in)
- 3. Command that they all be combined as one (I command in the name of Jesus that every demon of \_\_\_\_\_\_ be immediately welded together as one)
- 4. Ask the demon, "Has everything in the house has been repaired, is everything is packed up, is everyone combined together as one, and does this stand as truth before Jehovah God" (God the Father)

# The commands to cast out a demon

In the name of Jesus Christ, I command the king of (problem area) \_\_\_\_\_\_\_to step forward and stand at attention before Jehovah God. In the name of Jesus, I strip you of your power and authority and take every promotion that you have ever been given. I command in the name of Jesus that you pack up the everything that you brought into the house. I command in the name of Jesus that you repair all the damage that you have caused. I command in the name of Jesus, that every demon of (name the affliction once again) be welded together as one with your works, your associated works, the residue of your works and all your associated demons. In the name of Jesus, have you packed up everything that you brought into the house? Have you fixed everything that you have damaged and has every demon of \_\_\_\_\_\_been combined? Does all this stand as truth before Jehovah God?

- Yes? I command that you go straight into the abyss carrying everything out that you brought into the house. In the name of Jesus, I command that you never come back. Get out now. In the name of Jesus, I command that you leave now. Go now into the pit. (Keep commanding the oppression to leave. You will feel or see the release when it goes)
- No? Do you have a legal right? Yes or no?
  - Yes? In the name of Jesus, what is your legal right? Keep pressing in the name of Jesus and they will tell you. Break the "legal right" and make it leave
  - No? Then you have to leave or I will have you tried before Jehovah God for disobeying the name of Jesus.

# Deliverance commands to begin a deliverance session

(Fill in blanks with the name of the deliverance candidate)

-In the name Jesus Christ I bind every blocking and hindering demon and break every assignment on anyone in this room. In the name of Jesus Christ, I break all assignment to stop this deliverance and command that every associated demon leave immediately.

-In the name of Jesus Christ, I take authority over this space and command all principalities and even satan himself to return to the heavens. I command that no assistance be given to any demonic power in . I also command that you do not send any new demonic powers into

-In the name of Jesus Christ, I command that the only way a demon may move is out, away, and into the pit of hell.

-In the name of Jesus Christ, I command that above all senses, you use the sense of speech. I command that you speak clearly through \_\_\_\_\_\_\_ or to the conscious mind of so that we can clearly understand everything being said.

-In the name Jesus Christ, I put every demonic power under oath before Jehovah God and command that you tell the truth, the whole truth, and nothing but the truth before Jehovah God.

-In the name of Jesus Christ, I command that all demonic powers associated with

whether here, away, in hiding, sleeping, using some form of trickery, roaming free or in the subconscious come out of every room of the house and be gathered in the center along with your works, your associated works, the residue of your works, and all your associated demons.

-Now in the name of Jesus Christ, by the calling of the great commission, the power of the blood of Jesus Christ my Savior, and by the authority given to me in Luke 10:19, I take absolute control over every demonic power in this house. You will hear my commands and you will obey in the name of Jesus Christ my Savior, or you will be judged in the court of Jehovah God. I command in the name of Jesus that every demonic power stand at attention before Jehovah God. I bind every demonic power in the house, and command in the name of Jesus that every demon be put into holy handcuffs and holy chains. I command that you do not move. -Now in the name of Jesus Christ, I command the king of (problem sin area) \_\_\_\_\_\_\_\_\_ to step forward and stand at attention before Jehovah God.

# **Session 5: Attributes of Demons**

## **Demons vs demon groups**

Most deliverances that are being done are partial deliverances where one or a few demons that are manifesting or affecting the person are cast out. This is great at the altar or in public, but almost all demonic oppression comes in demon groups. There are always many more than a couple of demons. You may cast out a demon of fear, but there will many times be many demons of fear, and they will all have different assignments. Fear of heights, fear of crowds, fear of failure, etc. The list will go on and on. The demonic will offer up one demon of fear to be cast out while keeping the entire kingdom of fear intact. There are always leaders of every demon group, and the demon groups will be ranked like an army or the mafia or even a video game. There will be many sub-bosses, but you must defeat the main boss, the strongman, the one in charge to defeat the army. In a deliverance, you always must go for the one who is ranked #1 to get a complete deliverance. When he is identified and cornered, then you can make him carry out all the other demons that are in the house. The demons in each kingdom will have rankings such as king, commander, captain, lieutenant, corporal, privates, and plebes. Plebes are the lowest ranked demons. This word comes from Roman society where the plebes were the lowest ranked citizens. Plebes are the slave class, and the demons hate to be reduced to the rank of slaves. When this happens, the person will be free.

# Common demons and kingdoms

## The Potential Strongman / Boss / Kings

#### Fear

**Apollyon / Abaddon** - This is the most common strongman / boss of a person. 90% of the time this demon will be #1. Fear, anxiety, worry, low self-esteem, sadness, regret, insecurity, loneliness, failure, worthlessness, shame, inferior, depression. Apollyon – Greek for destroyer / Abaddon –Hebrew for destroyer

#### Destruction

#### Beelzebub most of the time.

(Usually assigned to ministry people and pastors) Potential strongman in ministry people. Destruction is a quite common demon on Christians that will bring death, disease, cancer, sickness, allergies, division, pride, adultery, poverty, pestilence, etc. When destruction is on a person or their family, everything demonic will work together to destroy that person's life, their family, their relationships, and their ministry. This Kingdom will usually be scorpions or locusts. They will be ranked like an army from King, commanders, captains, princes, plebes, etc. It can be a two headed dragon with twin kings, but one will always be ranked #1. This demon will be assigned to a person because of their calling. **II Timothy 1:9**. If you ask destruction if they have a legal right. They may tell you that it is because of the persons calling. This is a lie. A person's calling is not a legal right. It can be on a person because of a generational curse. Destruction can

also be brought in because of pride in a person's life. Proverbs 16:18 Pride comes before destruction.

#### Demonic kingdoms usually under destruction

**Death** – Usually named black or rancid. Ask which one (If death is there ask if it brought in cancer) If the answer is yes ask where it brought in cancer. Make sure it names where all the cancer is located. Ask death did it bring in disease and where it is located.

**Cancer** – It will always be under death. Command the specific areas of cancer to stand at attention. Spirit of breast cancer, you come to the front and stand at attention. Prostate Cancer, Bladder Cancer, etc. Ask the specific cancer if they brought in cancer cells. If the answer is yes, then command them to pack up all the cancer cells, fix the house, and combine every demon of the type of cancer together. When it is done, cast it out.

**Disease** – Disease will usually be snakes. Vipers or constrictors. Command death to tell you where it brought in disease. Go to those areas and ask if there are snakes there. Ex. The colon. Are there snakes on the colon?? Are there vipers, constrictors, or both? Ask how many of each. Vipers cause polyps, constrictors cause constipation. Command that the vipers pull out the poison and repair any damage, combine them together and cast them out. Command that the constrictors release the colon, fix anything that they have damaged, make them combine and then cast them out.

**Legion** – Pain (legion will many times be a kingdom of pain) It can be a viper injecting poison causing pain. Ask the demon if it is a viper and where it is located.

Baal – Self Harm (cutting)

Suicide – Brings a desire to die

**Poverty** – Destroys finances

**Dissention** – Destroys relationships

**Torment and Torture** – May cause skin problems, deformities, infestations, etc.

**Skin issues - Chiru** (This will manifest as a jellyfish over the head with stinging tentacles hanging over the body) ask for its name (eczema, rashes, shingles, skin allergies)

**Night Terrors -** Nightmares (May be **Baphomet**) They are either owls or bats but sometimes both. Ask if there is a kingdom of night terrors then

ask if they are owls or bats. The deliverance candidate will usually see the owls or the bats.

**Incubus / Succubus** Male sex demon / female sex demon (found with night terrors)

#### Abuse

Molech (physical or sexual), (molech is usually there with the victim of abuse or because of generational abuse.) Occasionally, you will find molech in a person who is an abuser.

#### Rape, Molestation, mental abuse, physical abuse

#### Lust

Astaroth / Marcus is always a viper wrapped around the neck injecting poison. Command lust to suck out the poison, release the neck, and fix the damage that it caused before leaving. Command it to pack up everything that was brought into the conscious or subconscious. It can be there from abuse, generational curses, or open doors

# Pornography, gender confusion, adultery, fornication, Sexual perversion

Maha Bones – Freemasonry. If anyone in the family has been in freemasonry, this demon will be there. They may not know that freemasonry is there. It can be from hundreds of years before. Cast it out first when you start a deliverance. It will try and stop the deliverance. This demon causes many infirmaries: Asthma, hay fever, emphysema, breathing problems, fear of death by choaking, throat problems, lung disease, liver disease, heart disease. The person may have trouble breathing as you deal with this demon.

# Demons to cast out first in the deliverance

#### Cast off every demonic power on the outside first combining them together as one

#### **Blocking and hindering**

	This will stop a person from hearing the Spirit and will hinder the deliverance. It will also stop them from receiving spiritual gifts
Deaf and dumb	This demon will stop the person from hearing and speaking in a deliverance. Cast it out at the very beginning of the deliverance.
Maha Bones	Cast this demon out first if their family participated in freemasonry
Orion	This demon always brings doubt and confusion. It is always an octopus that is on the head. It will put its tentacles into the person's head and affect the brain. It can be very stubborn. Strip it of its power, authority, and titles, and make it remove its tentacles from the brain before casting it out.

George	False Gifts – George will bring in false gifts. These will usually be counterfeit gifts of the spirit. False holy spirit, false word of knowledge, false prophecy, false tongues, etc. This demon will many times attach to a person's Spirit filled gifts but add to them twisting them into evil. It is usually found in spirit filled people and churches. A false tongue can actually curse others when praying over someone.		
Common demons found in many people			
Trauma	Trauma will be there if the person has suffered a car accident, rape, death		
Legion	Legion will be a large kingdom that can be associated with anything, but we find it most commonly with pain.		
Rage, Anger, Fury	The demons of anger will usually always identify as one of these but sometimes two. Ask which one it is. It is usually a bear. The person may growl or even see a bear. If this happens, ask who are you? Rage, anger, or fury.		
Jezebel	Rebellion and dissention. If Jezebel manifest, it will always be a crazy witch laugh. If the person starts laughing for no reason, then call out Jezebel.		
Ahab	Jezebel always wants an Ahab. The husband, wife, or kids of a Jezebel will usually have an Ahab spirit that is submissive to Jezebel.		
Delilah	Buddies with Jezebel. If you find Jezebel, the person will usually have a Delilah spirit there also. She will say Jezebel is her friend.		
Leviathan	It will twist what a person hears or says to others, making them hear something different. It will also twist scripture. It brings division. This demon is a sea serpent		
Allergies	Allegra / Claritin / Zyrtec the demon in charge of allergies will usually be one of these three but sometimes two or all three.		
Religion	Spirit of Religion is usually but not always found in people who have attended Baptist, Presbyterian, Lutheran, Catholic, Episcopal, and other traditional churches. It can be difficult to make leave. Many times, you must get the person to renounce religion and make them say that they want a relationship with Christ, not religion. It will manifest by quoting scripture even singing hymns when confronted.		
Poindexter	Blasphemy This demon will be considered the court jester. He will blaspheme God and make all the other demons laugh. He is rude, arrogant, and thinks he is funny.		
Profanity	This demon just brings profanity. If you see a believer who is dealing with profanity or coming close to profanity, this will be there.		

Peter Pan	Arrested development. This demon wants to keep the person in a childlike state, not accepting responsibly.
Kundalini	This demon is the new age demon of witchcraft. It is brought on by Yoga and new age practices such as reiki. Yoga means to yoke, and the different forms are yoking the person with demonic entities Hinduism. It is a serpent that wraps around the lower back and can destroy the back and bring pain. It is stubborn.
False Healing	Healing that is brought upon the person for replacing Godly healing with other types of healing. This can be stones, vibrations, acupuncture, oils, etc. Ties to new age.
Witchcraft	Any agreement with witchcraft or involvement with the occult will bring on a spirit of witchcraft. Of course, that will include ouija boards, tarot cards, horoscopes, healing crystals, but it can also include harry potter, Disney princess movies watched over and over, school plays with witchcraft, and video games.
Migraines	Migraines are always spiders in the head. Command all the spiders in the head to combine as one. Make them take out their webs and remove their eggs as they leave.
PTSD	Post traumatic stress disorder
OCD	Obsessive Compulsive Disorder Brings a demon of perfection
ADD/ADHD	Attention deficit disorder Stops a person from focusing
Gluttony	Overeating
Overindulgence	Makes people overindulge or want to much of a good thing.
Sloth / laziness	Laziness the person may see the sloth
Judgement	This goes with justice. You want the people who have done wrong to be judged by God for their wrongdoing
Justice	This makes a person constantly demand justice for things that they believe are not right.
distrust	
Distraction	Distracts the person from everything from their job to their ministry
Control	Seeks to control people
Pride	People with Pride will many times have destruction. 18 Pride before destruction goeth, And a haughty spirit before a fall. Proverbs 16:18
Pharmakeia	This demon comes with covid vaccines. Make it pack up all the poison that was brought in and repair all the damage that was done before casting out. Person may see this as worms in their heart or circulatory system.

Covid	Look for a covid demon if the person has had covid or has covid	
Speed Demon	Makes people bite their nails	
Butterworth	Candida / Yeast / fibromyalgia / lupus / inflammation This demon can bring debilitating inflammation to the body causing extreme fatigue and pain.	
Snakes	Snakes are always constrictors or vipers. They are always found on organs, bowels, circulatory systems, on the esophagus, and around the legs. They will attack the reproductive organs of a woman causing cyst on the ovaries or injecting cancer cells. They will wrap around the colon injecting poison to cause polyps or constricting to cause constipation. They will wrap around the heart to cause chest pain and inject poison to bring heart disease. They will wrap around the throat and constrict to cause breathing problems and around the legs to cause circulation problems. In a deliverance, if a person is having pain somewhere, you can ask if there are snakes there and you will get a yes or no. When you get the answer ask if it is constrictors or vipers and they will tell you. Sometimes we will ask for the numbers. How many vipers are on the colon? They will usually lie but keep pressing and commanding that it stand as truth before Jehovah God. You will get the number. Ask how many constrictors. Next combine all the constrictors together and cast them out, then combine all the vipers together and cast them out. You can do this wherever you find snakes.	
Wotiege	On the pancreas. It is a squid that stops insulin production bringing diabetes	
<b>Demons from their mother</b> (under mother's name This will be there in every candidate if it has not been cast out)		
<b>Demons from their father</b> (Under father's name. This will be there in every candidate if it has not been cast out)		
<b>Demons that impersonate the deliverance candidate</b> (false) the person's name		
<b>Demons from soul ties</b> will be under the name of the person with whom the soul tie was formed.

## **Session 7: Deliverance Technicalities**

## How demons attach and come into a host

We and other deliverance ministries have found that demons will usually attach on the outside of a host first. They will then wait for an open door to enter the person. When the door is open, the demon will split or divide allowing half of the demon to come into the person while the other half remains on the outside of the person. We normally cast-off demonic oppression on the outside first. We command that all demonic powers on the outside combine as one, and we then command in the name of Jesus that everything on the outside go into the pit. You will usually always find mirrored kingdoms on the inside and the outside of a person. After this is done, we begin the deliverance with the kingdoms on the inside.

## **Getting Slimed**

We have found that after every deliverance session it is usually necessary to do self-deliverance and command that every demon that has attached to the outside of you be stripped of their power and commanded to go into the pit. Many times, you will feel the heaviness after a deliverance session. This will usually be from demonic oppression that may have attached to you during the deliverance. It does not mean that it has come in, but that it is sitting outside waiting to come in with an open door.. his is not a big deal and goes with the territory of doing deliverance. Some pastors will try and argue that this does not happen, but it does happen. Anyone doing deliverance on a regular basis will agree that you will feel the heaviness after a deliverance session. Command that every demonic power on the outside of you combine as one, strip them of their power, and cast them into the pit.

## Do deliverance on each other

As you become more experienced in deliverance, you will begin to recognize obvious oppression on others. On the same hand, the people that you are working with you in deliverance will begin to recognize oppression on you that you may have missed. It is important to always be open to receiving deliverance from those whom you trust. Many times, you will run across believers that are working in deliverance who are arrogant and prideful. They will reject any suggestion that they may be dealing with oppression themselves. Do not be one of these people. Be open to those around you who may see things about you that you do not. Constantly help your brothers and sisters in Christ by helping set them free. We must walk in humility and not pride. Pride is the biggest pitfall for deliverance ministers and pastors. It always comes before destruction. Always operate in humility because others will always see things that you will not. Work with each other to stay free, constantly asking guidance from the Spirit because you will always be under attack, and you will need help.

## **Removing Demons passed to children from parents**

In deliverances, you will run across demons in parents that have obviously been passed to their children. This usually happens by the demon splitting and passing into the children. If the children are under legal age, you can command that the demon in the parent bring back the part that was split and passed to the child or children. This is done by asking if the demon was passed

to their kids. The parent will hear a yes or no or the demon may speak through them giving you a yes or no. If it has been passed, then you ask if the demon can bring the others back from the child or children and make them combine back together in the parent. Then they give you a yes or no ask if this stands as truth before Jehovah God. Once again you will get a yes or no. If they are under eighteen, it should be a yes. Call the demon out if it says otherwise because they are lying. Command that the demon bring back every demonic power that was passed to the kids and combine as one back into the parent. When everything is combined as one, then you can cast it out of the parents, and it will pull it out of the kids.
