

## Qualifications for a Deliverance Session

1. Read the book When Pigs Move In by Don Dickerman.
2. Watch the video Casting Out Demons II Q & A by Isaiah Saldivar.
3. Watch the video How Deliverance Works with Don Dickerman.
4. Fill out the deliverance intake form
5. Pray through the prayers to break curses and legal rights of the enemy.

If a candidate is prepared for deliverance, then a counseling session should usually only take around two hours. A session may go much longer if the candidate comes to the session unprepared. To ensure the success of a deliverance, and to make sure the deliverance session is conducted in a timely manner, please read these qualifications first before beginning the paperwork. This form should be signed after reading Don Dickerman's book, watching the videos, and filling out the paperwork. Failure to meet the qualifications may result in your deliverance session being cancelled. We work extremely hard to help set people free through the power of Christ, however; we do expect the candidate to do their part to educate themselves before the deliverance. Please contact us before the session if you could not answer yes to any of these questions.

## **Breaking the legal rights of Spiritual Oppression**

**This must be done before the deliverance candidate comes for the deliverance session.**

**Unforgiveness:** For a deliverance session to be successful, the deliverance candidate must make sure that there is absolutely no unforgiveness in their lives. Matthew 18:23-35 explains that because we have been forgiven our sins by our Heavenly Father, and He expects us to do the same for all others in our lives no matter how they have wronged us. Failure to forgive others gives the enemy the right to bring oppression. Please pray the following prayer focusing on forgiving those who have wronged you.

### **Prayer for forgiveness**

Lord, I choose to forgive all those who have sinned against me, hurt me, or even abused me. I repent of all unforgiveness for others and confess it as sin. Lord, I want to specifically forgive (name the people that you may have struggled to forgive,) and I also choose to forgive myself. Thank you for your grace, mercy, and love. Amen

### **Prayer for renouncing witchcraft and ungodly activities**

Lord, I renounce any ungodly activities or agreements that I made knowingly or unknowingly with satan or the demonic realm. I confess these ungodly oaths, activities, and agreements as sin, and I break every agreement, attachment, and oath in the name of Jesus Christ destroying any legal rights of the enemy. Amen.

### **Prayer for renouncing false religions.**

**In the name of Jesus Christ, I renounce all associations that I or my ancestors may have had with false religions or false gods.** I confess all these associations as sin and break any legal right to my life that the enemy may have because of these connections. Amen.

### **Prayer for breaking ungodly relationships**

Lord, I want to renounce every ungodly relationship that I may have had as sin. I call back every part of me that was given to another, and I give back every part of others that I may have taken. In the name of Jesus, I break every ungodly soul tie that I have made and choose to be free from every ungodly attachment. Amen.

### **Prayer for breaking generational sins and curses**

Lord, right now I ask that all the sins of my fathers and forefathers and every attached curse be brought before you. We know that the blood of Your Son covers all sin and turns every curse into a blessing. Lord, I confess and denounce the sins of my ancestors, and ask that the blood of Your Son be applied to every sin and curse in my lineage. Father, thank you for forgiving these sins and separating me from the curses on my life. Amen.

## Finding Freedom Ministry FAQ's

### **Is there a cost involved for a deliverance session?**

Yes. There are always costs involved in a ministry. Lawyer fees, accounting and bookkeeping cost, webpage design and maintenance, insurance, supplies, literature, and payroll. Currently all deliverance sessions are conducted on a volunteer basis, however; we do compensate our intake and scheduling administrators. We believe that deliverance and deliverance sessions should be conducted as part of a church's ministry which is supported by one's tithes to their church. We understand if your church is not providing deliverance counseling, and Finding Freedom Ministries will conduct a deliverance session providing the candidate meets the requirements. When a person comes for a deliverance session, someone is paying for the session, even if the deliverance candidate chooses not to donate. Our ministry operates intentionally independent from churches and denominations, and because of this, **we recommend a deliverance candidate donate a minimum of \$200 per person** to help offset the cost involved in the ministry. We also have a PayPal and Cash App account on our website. You may also want to partner with our ministry by becoming monthly donors. Finding Freedom Ministries vision is to bring deliverance training and deliverance programs to churches across the nation. Your donation is being used to directly destroy the kingdom of Satan. Finances are never a hinderance to being set free so do not let your inability to donate stop you from coming for deliverance. If you cannot donate the recommended \$200, then please let us know your situation.

### **Do we do phone deliverance?**

We normally try to stay away from phone deliverance sessions, however; we all have the same authority in the name of Christ in person or over the phone. We can do telephone or zoom deliverance sessions in special situations. Please contact us to explain the situation.

### **How long is the session?**

It usually lasts one to three hours depending on the situation.

### **Do I need to complete the qualifications sheet before making an appointment?**

Yes. You must read the entire book, *When Pigs Move In* by Don Dickerman. You must also watch the required videos that are listed on the Deliverance Intake Form, and completely fill out the Deliverance Intake Form. We will not schedule a deliverance session until these requirements are complete. Please do not call and ask to be put on the schedule because you are reading the book and planning to be done in time for your session. This has been an issue in the past and candidates will show up unprepared for their session. It is for this reason that all requirements must be complete before you are put on the schedule. Also, please be truthful about meeting the qualifications as this may lead to difficult or canceled sessions.

**Where are deliverance sessions conducted?** Some sessions are conducted in Suffolk VA, however; sessions may also be conducted at local churches that are in alignment with the ministry. We will give you times and locations to choose from when you are scheduled.

### **Can I bring someone with me for my session?**

We normally do not allow anyone other than our team members and trainees to take part in a deliverance session. Many times, things are revealed in a deliverance session that need to be

kept private. We have also had situations where husbands or wives that have not been through deliverance begin to become a distraction because they have not been set free. A person's session should be between them and the Lord without outside distractions. We may be able to provide a separate waiting area for family and friends or for multiple sessions. Please explain your situation before coming to your session so that we may try to accommodate.

### **Are children allowed to go through deliverance sessions?**

Yes. Kids are great and their sessions usually go much smoother than adults. They usually have less baggage. In younger children, we require the parent to be present in the deliverance. The parent must have gone through deliverance before bringing the child. Depending on the age of a teenager, the parent may not need to be present. A parent can sometimes be a hinderance to a teen's deliverance.

### **Is there training available?**

Yes. The vision of Finding Freedom Ministry is to train believers and ministries in deliverance. We are actively scheduling training classes and seminars for churches as well as church leadership training. If you feel that you are being led into the deliverance ministry, we will allow you to sit in on sessions after you have gone through a deliverance session with our team. This allows for very personalized individual training. If your church, pastors, or ministry leaders have a desire to be trained in deliverance or deliverance sessions, please contact our ministry. We will also travel to ministries to educate and train pastors and ministry leaders in deliverance. This will include deliverance at the alter as well as setting up weekly deliverance sessions in the church.

### **Is there a waiting list?**

Yes. Typically, there may be a one to two month wait, sometimes more and sometimes less.

### **How do I set up a deliverance session?**

Setting up your deliverance session is a process. There are requirements that must be completed before you are scheduled. We do this so that the deliverance candidate is educated on the deliverance process before they come to their session. A deliverance session should take one to three hours. Most of that time is spent explaining the process and identifying the areas of oppression before we begin the deliverance. The actual deliverance is usually around one hour. If a person shows up without understanding the process, a session can take three to four hours. If the person is serious and wants to be set free, they will put in the effort. When this is done, things usually go very smoothly.

To start the process, go onto our website, download, and print the Deliverance In-take form. Read the form and make sure you meet the qualifications for deliverance. Qualifications include having accepted Christ as your Savior, involvement in a local church, etc. If you meet the qualifications, then you must fulfill the requirements such as: reading the Don Dickerman book *When Pigs Move In*, watching the required videos, and lastly, filling out your paperwork. This is explained on the deliverance intake form. When this is **ALL COMPLETE**, send the paperwork to [findingfreedomdeliverance@gmail.com](mailto:findingfreedomdeliverance@gmail.com), and we will put you on the schedule giving you a choice of days and times for your session. We will not schedule your deliverance if you have not completed all the requirements. Please do not call and ask to be put on the schedule because you are almost done reading the book, and please do not lie about meeting the qualifications or the requirements. Yes, this has been an issue. We have found that proper

preparation makes deliverance sessions quick, effective, and successful. We have also found that not meeting the qualifications or lack of preparation leads to a lengthy deliverance session at best or failed deliverance sessions at worst. If you show up for your session not meeting the qualifications or not completing the requirements, your session will be cancelled. We spend a great amount of time and effort preparing for your session, so we expect the same dedication from the deliverance candidate.

### **When are deliverance sessions conducted?**

We strive to schedule deliverance sessions during the day on weekdays, however; they may also be scheduled at night or on the weekends depending on the availability of our volunteers. Please understand that it is your responsibility to work around our schedule just as you would in making a doctor's appointment. We will offer specific days and times that we have available and allow you to choose.

### **Can anyone go through a deliverance session?**

No. Please download and read the deliverance intake form for the qualifications. A candidate must have accepted Christ as their Savior and be living with Christ as the Lord of their life. We constantly pray with people and do quick deliverances in the church or at the alter to break specific issues like generational curses, addiction, lust, rage, etc. These short, specific deliverances are great to help set a person free in specific areas, however; we do not do full deliverance sessions on people that want a quick fix. Full deliverance sessions are reserved for strong believers that want to be completely free from all oppression. It requires a dedicated relationship with Christ and "clean" living to stay free, otherwise; their oppression will quickly return.

### **Can deliverance fix your marriage, your addiction, your relationship with God?**

Yes and No. You may need to go through sozo, inner healing, or counseling to make sure that all issues with unforgiveness, bitterness, anger, resentment, disappointment, or addiction are resolved before coming to a deliverance session. We have partnered with others offering these services, and we can refer a candidate according to their needs. We have found that many amazing inner healing programs are "light" on deliverance, and many deliverance ministries are "light" on inner healing. It is difficult to be proficient in both these areas at the same time, so we usually recommend diverse sources for each of these ministries. Deliverance and healing can strengthen your relationship with Christ, but it is your relationship with Christ that will fix your marriage, your addiction, and your problems.

### **Once I go through deliverance will I need more deliverance?**

Yes. Asking this question is like asking do I need to continue to pray or continue to read God's Word. Of course, you do. The answer to this question really relies on the commitment of a believer to live a God centered life. If you were able to live a life that is sin free, never opening doors to oppression, then you would never need deliverance again. Sadly, that is not reality. We are created with a sinful nature, and we will stumble. Many times, deliverance will change a believers walk with Christ because they come to the realization that they must live "clean" to remain free of oppression. The person realizes that there are actual consequences to sin. Breaking off oppression from small open doors is like killing an occasional bug that comes into a house. It is not a big deal, however; there will always be those who go back to their ungodly lifestyle. It is like pouring honey all over the kitchen floor and going away for a week. The

house may become completely infested with ants and a huge problem to clean up. If you choose to walk the line with the world or continue to live an ungodly lifestyle, invariably, you will become “reinfested” because of ungodly choices.

### **Who do I call if I need more deliverance?**

Let’s answer this question with a few other questions. Who do you call when you need to read the Bible? Who do you call when you need to pray? Who do you call when you need to eat? No one! You do it yourself. Now there may be situations where you need help reading the Bible, praying, or even eating, but those things are usually our responsibility. At some point, we all learned how to read, how to pray, and even how to eat. You absolutely must learn to walk in deliverance and freedom. In Luke 10:19, we are given authority over all demonic oppression. In Mark 16:17, the first sign of a new believer is that they will cast out demons. This is not a Spiritual gift. It is part of your Spiritual walk just like prayer and reading scripture. Do not let your walk with Christ be destroyed because of your lack of knowledge. There are now many resources available to learn how-to walk-in deliverance. Use the books, videos, and the Word to begin to educate yourself. We recommend Don Dickerman’s book “*Keeping the Pigs Out*” for post deliverance training. Walking in deliverance is your responsibility and should be part of your daily walk.

### **Will Finding Freedom Ministries help me remain free?**

Finding Freedom Ministries is like a body shop that repairs wrecked cars. If you set up an appointment and bring in your damaged vehicle, we can help repair the damage through the power of Christ. When you leave the shop, it is your responsibility to take care of your vehicle. You would never call the body shop because you made a mistake and drove through a huge puddle covering your car with mud. You would clean the car yourself and be embarrassed that you made a dumb mistake by driving through the mud. That same person will call us after their initial deliverance because they became upset with someone and allowed a spirit of bitterness and unforgiveness back into their life. Please do not call us after your initial deliverance for issues that God has given you the authority to handle yourself. Forgive the person, renounce unforgiveness, and cast it out in Jesus’ name. We have put together a training manual for free on the website. It has all the commands and information needed to operate in deliverance. Links to resources are also available on the website. We consistently receive post deliverance calls from people who do not want to walk in self-deliverance. They want someone to constantly do deliverance for them. Do not be that person. Educate yourself and learn to make deliverance part of your daily walk. Use your friends and prayer partners for daily maintenance. If you do not have friends or prayer partners, we can recommend people and churches for counseling. We also have post deliverance pastors that may help in counseling, however; deliverance should become part of a believer’s lifestyle. If all else fails, and you need an additional deliverance session because of an ungodly lifestyle or ungodly choices, please email us with your situation. If it is within six months of your original deliverance, we will normally charge \$150 per hour with a two-hour minimum.

### **How much time is invested for a deliverance candidate to be set free?**

On average we spend between 4-7 hours between phone calls, paperwork, emails, questions, and the deliverance session.

### **What are your office hours?**

Our office hours are 9-3 Monday to Friday. We normally do not take calls on weekends or at night. You may email us, and we will usually contact you within 48 hours by phone, email, or text.

### **Is a deliverance session like you see in the movies?**

No, our sessions are not like the movies. A deliverance session is a counseling and a prayer session. We try to do deliverance sessions in a relaxed and comfortable environment. We normally sit facing each other on couches or in recliners if possible. The more relaxed and comfortable the smoother the deliverance session flows. A deliverance session is not a ritual or a screaming session. We never touch the deliverance candidate during the session, nor do we use crosses or Bibles to lay on a person like the movies. You cannot fight the spiritual with the physical. You destroy the oppression with the authority you have been given in the name of Jesus. We do not allow the candidate to fall on the floor, vomit, or suffer in pain through a deliverance session. If severe manifestations begin to take place, we command the demon to stop manifesting, or we will stop the deliverance session until the manifestation is under control. In hundreds of deliverance sessions, we have never restrained a candidate or had anyone injured because of a manifestation. If a stubborn demon will not leave after we have broken their right to oppress, we do not scream at the demon for hours like you may see in the movies. In these situations, we open a court before God the Father, and have the demon found guilty of disobeying our authority in Christ. The demon is then removed, and the deliverance continues. A deliverance session should be an amazing and joyful event. Many times, we will laugh with the candidate during a deliverance because of some of the bizarre attachments that may be there. Most people leave saying their session was amazing and not what they expected. Movie and tv exorcisms have been produced under demonic influence and are created to terrify people. Of course, a true deliverance session is nothing like what you see in the movies or on TV. They were produced by demons.

### **Who will be in my deliverance session?**

In most situations, there will be two to three people. There will usually be one person that leads the deliverance session with one or two others that assist by praying and discernment. In most of our deliverance sessions, the third person will be a trainee learning how to conduct a deliverance session.

### **What is the most common oppression?**

There will always be a strongman or one that oversees a person's oppression. Everyone is different, however; fear is the dominate oppression in most people. This will usually include depression, anxiety, rejection, worthlessness, sorrow, etc. These will usually all fall under the kingdom of fear. A demon of destruction will almost always be on ministry people including pastors. It will try and destroy a person's relationships, finances, ministry, health, and their life. These demons are assigned to a person because of their calling. Lust will be there from generational sins, pornography, promiscuity, rape, and molestation. Abuse will be there from rape and molestation. Trauma will open doors to fear and anxiety. Addiction will often be passed down generationally. Physical problems from cancer and disease to breathing issues and bowel problems can be demonic in nature and many times generational. Oppression is very complex and is different in each candidate.

**Assumption of Risk:** Candidate understands, is aware of, and assumes all risks inherent in participating in the prayer ministry. These risks include, but are not limited to, physical and emotional responses and reactions as a result of this Prayer Ministry.

**Indemnity:** Candidate agrees to indemnify Releasees from any liability, loss, damage, or cost Releasees may incur due to the participation by Candidate in the prayer ministry whether caused directly or indirectly by Releasees or otherwise. Candidate assumes full responsibility for and risk of bodily injury, death, or property damage due to negligence of Releasees or otherwise while participating in the Prayer Ministry. Candidate expressly agrees that this Voluntary Release, Assumption of Risk, and Indemnity Ministry Agreement, herein referred to as "Agreement," is intended to be as broad and inclusive as permitted by the laws of the State of Virginia and that, if any portion of this Agreement is held invalid, it is agreed that a balance, notwithstanding, continue in full legal force and effect. This Agreement contains the entire agreement between the parties in regard to the Prayer Ministry. The Candidate also acknowledges that they understand and agree that:

1. This is a ministry of Finding Freedom Ministries Inc., Incorporated, providing Prayer Ministry in individual and group settings. Our Prayer Ministry is done by pastoral staff and lay-ministers, herein referred to as "Ministers", who are not licensed as professional counselors, in the State of Virginia.
2. Under normal circumstances, your Minister will use their good faith efforts to keep all your discussions in confidence, however; you should be aware there are some situations



in which your Minister may be required by law to report information to the proper authorities without your permission or knowledge. These situations include but may not be limited to a Candidate's indications of harm to self or others, involvement in a felony, suicidal intentions, and/or reasonable evidence of child or elder abuse or neglect. Your Minister may also disclose information in response to a subpoena issued by a court of law.

3. Officially recognized ministry staff and lay-personnel may have limited access to your ministry file. Any other person seeking access to your ministry file may do so only with your written permission

4. Finding Freedom Ministries Inc. requires that parent(s) must be actively involved in any Prayer Ministry that is extended to a minor child as determined by the Minister. At the discretion of the Minister, parent(s) will be required to make themselves available and accountable for active participation in Prayer Ministry offered by Finding Freedom Ministries Inc.

5. Candidates with any concerns or questions about this agreement agree to raise them with their Minister at the earliest possible time.

6. This agreement, herein referred to as the "Voluntary Release, Assumption of Risk, and Indemnity Ministry Agreement", will govern all relations involved during the term of the Ministry process. It is agreed that any disputes or modifications of this Voluntary Release, Assumption of Risk, and Indemnity Ministry Agreement will be determined directly between the individuals involved. If this Voluntary Release, Assumption of Risk, and Indemnity Ministry Agreement is not satisfactory, then it is further agreed that disputes and disagreements will be taken to the Finding Freedom Ministries Inc Board for dispute resolution. In the event that a satisfactory resolution is not achieved, then it is further agreed that a mutually acceptable third-party arbitrator will be utilized. All expenses incurred will be the responsibility of the party bringing the dispute.
